

CALIFORNIA EMPLOYEE, INDEPENDENT CONTRACTOR AND JOB APPLICANT PRIVACY NOTICE

Last Updated: April 30, 2025

Under the California Consumer Privacy Act of 2018, as amended by the California Privacy Rights Act of 2020 (“CPRA”), Forian Inc. and our subsidiaries (collectively, “**Forian**,” “**we**,” “**us**” or “**our**”) are required to notify you that we collect certain personal information in connection with your employment, application for employment or independent contractor relationship. A list of Forian’s subsidiaries can be found in the List of Subsidiaries filed as Exhibit 21 to Forian’s most recent Annual Report on Form 10-K, available under the Investors tab of our website, located at www.forian.com.

In particular, we collect, use and disclose the following categories of personal information regarding job applicants, employees and their emergency contacts and beneficiaries, and independent contractors:

Forian does not have actual knowledge that it sells or shares such information of children under 18 years of age.

The personal information, including the sensitive personal information, described above are collected directly from you when you apply for employment and during your employment or from other sources such as benefit providers, third parties for reference checks (e.g., past employers), recruitment agencies, background check agencies, timekeeping software, internal or third-party tracking of usage of Forian email and telephone systems and computer networks, public agencies (e.g., tax authorities, the California Department of Fair Employment and Housing, the California Labor Commissioner, the California Occupational Safety Administration, and if applicable to the position, the California Department of Motor Vehicles), workers’ compensation carriers, law enforcement agencies and litigation.

We use the personal information, including the sensitive personal information, described above only for business purposes related to your employment or independent contractor relationship. Those purposes may include:

- To evaluate an applicant’s qualifications and suitability for employment;
- To evaluate an employee’s performance;
- To administer pre-employment and post-employment tests and training activity;
- To complete the onboarding process;
- To conduct criminal and other background checks;

- To manage the terms and conditions of employment, such as payment of wages/salary, direct deposit authorization, the provision and administration of benefits and leaves of absence and maintenance of emergency contact information;
- To process work related claims (e.g., insurance claims);
- To prepare and maintain legally required records, such as I-9 forms, EEO-1 forms and affirmative action plans;
- To provide a safe work environment;
- To manage employee timekeeping;
- To maintain information regarding training, disciplinary action, injuries and other employment history;
- To ensure compliance with company policies and regulatory and legal requirements;
- To meet tax obligations;
- To detect security incidents, protect against malicious, deceptive, fraudulent or illegal activity and prosecute those responsible for that activity; and
- To achieve other operational purposes for which the personal information was collected that are compatible with the context in which the personal information was collected and our employment or independent contractor relationship.

We will retain the personal information, including sensitive personal information, described above as long as necessary to fulfill the purpose for which it was collected or as required by applicable laws or regulation.

CPRA Rights

As a California resident, you have the following rights under the CPRA:

Right to Know: You have the right to request that we disclose certain information to you about our collection and use of certain personal information, including sensitive personal information, about you as described below:

- The specific pieces of personal information collected;
- The categories of personal information collected;
- The categories of sources from whom the personal information is collected;
- The purpose for collecting, selling or sharing the personal information;
- The categories of third parties with whom we have disclosed the personal information;
- The categories of personal information that we have sold or shared, and the categories of third parties to whom the personal information was sold or shared, by category or categories of personal information for each third party to whom the personal information was sold or shared; and

- o The categories of personal information that we disclosed for a business purpose and the categories of persons to whom it was disclosed for a business purpose.

Right to Delete: You have the right to request that we delete your personal information, subject to certain exceptions.

Right to Correct Inaccurate Personal Information: You have the right to request that we correct inaccurate personal information we maintain about you, taking into account the nature of the personal information and the purposes of the processing of the personal information.

Right to Opt-Out of Sale or Sharing: Forian does not sell personal information to third parties for monetary consideration. However, certain sharing of information with our third-party analytics and digital advertising vendors may qualify as a “sale” and is considered “sharing” under the CPRA. This data collection is not directly related to your relationship to Forian as our personnel but may be collected from any user of our websites generally. To opt-out of certain sharing of information with our third-party analytics and digital advertising service providers, you may set your preferences to reject analytics and advertising cookies by clicking the “Do Not Sell or Share My Personal Information” link at the bottom of the Forian website located at <https://forian.com/>.

Right to Limit the Use and Disclosure of Sensitive Personal Information for Certain Purposes: As stated above, we do not use or disclose your sensitive personal information for any purpose other than those permitted under the CPRA.

Freedom from Discrimination: You have the right not to receive discriminatory treatment for exercising your rights above, including not to be retaliated against for exercising such rights.

To submit a verifiable request, you will be asked to provide certain information to help us verify your identity. The information we ask you to provide to initiate a request may differ depending upon the type of request, the type, sensitivity and value of the personal data that is the subject of the request, and the risk of harm to you that may occur as a result of unauthorized access or deletion, among other factors.

You may designate an authorized agent to make a request on your behalf by providing the agent with signed written permission to do so.
